# THE IDOLATRY OF GOVERNMENT

## THE FALL OF "THE NEW WORLD,"

### And The Folly of Petitioning The Beast For Help

**O**NCE upon a time there was a land called "The New World." This land was located on a distant, vast continent. It had mountain ranges with snow-capped peaks, virgin forests beyond measure, pastoral valleys and prairies with rich soil, pristine rivers and lakes, and plentiful wildlife.

It was called "The New World" as compared to "The Old World" of Europe and Britain. The New World was yet unsettled and un-exploited by the exploiters of The Old World. They had not yet taken control of this distant land. They knew of its existence and fully intended to exploit it in the future. However, to facilitate exploitation a new land needs pioneers to first settle it and establish families, communities, farms, and businesses for those are the facilities required for banking and legislation to take over and exploit a land. They needed people and commerce on the land first, as that was the medium the "Serpent" culture needed in which to grow.

The New World, which came to be called "America," was still free and healthy – untainted by the ways of The Old World's Beast System. This unspoiled land was at once seen as a sanctuary of hope for freedom seekers who dreamed of liberty and escape from The Old World and its oppression from the government and the bankers.

But, the journey to The New World was very long, and very expensive. Freedom seekers who could afford the expense of chartering a ship and relocating across the ocean in America eagerly did so. There they found freedom and opportunity. They found life and the spirit of liberty for themselves and their children. The rulers of The Old World were not there to oppress them, suck the life from them, and rob them.

Resettlement in America was challenging at first. Battling the weather and diseases, and learning how to survive on the land proved challenging. The new settlements were few in number at first. But, as more and more people learned

of the advantages in The New World, the number of eager pioneers seeking freedom grew until there were several settlements and sea ports as well as inland communities.

Blessed by freedom (true freedom), and invigorated by the spirit of life, the pioneers in America learned to be self-sufficient. Within a few years they were producing more products than they needed for their own consumption, so they began exporting their excess products to other countries.

Life in America was as it should be. For those who were not afraid of hard work there was freedom, land, fulfillment, and a future heritage for one's family. America seemed like the promised land – and her vast resources seemed nearly endless.

Without the Beast System and its hordes of blood suckers, the New World offered a whole new way of life for people. It offered that which had been lost in The Old World. In America they could keep and enjoy the fruits of their labors without having them stolen by bankers' usury and government leaches, fees or taxes. In America, it was still possible to make a living without a banker or a politician there to take it from you. Back in The Old World personal property and security had long since been lost to the common man.

In The Old World, government (and the usury-banking system which it legalized) was a plague upon the land. The system stole or ruined everything the people produced. So, it was no wonder that the people were eager to learn of a different world without the oppression they had come to know in Britain and Europe.

### LAND OF OPPORTUNITY

America was still an unconquered wilderness. It was overflowing with opportunity.

What was it that made America the land of opportunity? Was it her vast ex-

panses?

No.

Was it her mountains, forests and rivers?

No.

Was it her fertile soil?

No.

Was it her favorable weather?

No.

Most of these elements were available back in Europe and the British Isles (The Old World).

What, then, was it that made life in America different? What made pioneers rush to America? What made them prosperous in America when they had been poor in The Old World? What made life good in America when it was dreary and hopeless in The Old World? What made men entrepreneurs in America when they couldn't even afford to own a business in The Old World? Why was life in America described as "free" while life in The Old World was hopeless?

The answer is simple. The obvious difference in the two worlds was **THE BEAST SYSTEM**. The Old World had it, and The New World didn't. That's it!

### THE IDOLATRY

In the Bible, man's government is figuratively called "Babylon." It derives its symbolic title from the ancient kingdom of Babel (Babylon), in Mesopotamia. Babylon was renowned as a world empire. It became the symbol and prototype for government-by-man. It also is symbolized by the "Tower of Babel" – a symbol representing central ruling power from a central location. In Bible terminology, Babylon is synonymous with Central Rule.

"Babylon The Great," described in the Book of Revelation, chapter 17, symbolizes the monolithic establishment known today as The New World Order. (By the way, "The New World" of the 1700's has nothing to do with the "New World Order" of today. "The New World"

was not an “order” ... it was a land.)

Babylon The Great still rides atop the international Beast System symbolized by a dragon (serpent) in Revelation 12 & 13. This serpent is a corporate conspiracy of bankers, politicians and militaries. Its power is achieved by controlling governments, which in turn legislate laws to legalize their crimes. Then, the churches brainwash the public to accept the whole program.

As I said, this beast is an organized conspiracy of **Finance, Government, and Religion**. These were the same tools used to seduce Adam in Genesis 3. These three were the tools of Egypt, Assyria, Babylon, Persia, Greece, and Rome ... by which they each acquired world domination. These three weapons are the perfected tools of plunder employed by Babylon the Great – otherwise called “*The Beast*,” “*The Great Red Dragon*,” “*The Old Serpent*,” “*The Adversary*,” and “*That Great City which reins over the kings of the Earth*.”

With these weapons, ancient Babylon conquered the nations of the known world. With these same weapons she reigns over the nations of the world today – and she will continue to conquer and control as long as the people keep worshipping her, submitting to her, and pledging allegiance to her.

God commands us to “*Come out of her, my people, that you partake not of her sins, and receive not of her plagues*.” To “come out of her” requires only that we stop voluntarily loving her and offering her control of all we have. In other words, stop believing in her.

For Babylon’s tools of banking, government and religion to be effective, the public must endorse and trust in her. Public disfavor would render her impotent.

Worshipping, or believing in, the Babylonian way of government is “idolatry.” Idolatry is the great sin of America, for in adopting the Babylonian way of government (i.e., men as lawmakers) America rejects God’s way of government. In other words, America created her own lawmaker (Congress), and rejected the true Lawmaker: Yahweh.

20. *Look upon Zion (New Jerusalem), the city of our assemblies: your eyes see Jerusalem a quiet home, a tent not taken down; not one of its stakes is removed, neither are any of her cords broken.*

21. *But there the glorious Yahweh is to us a place of broad rivers and streams; wherein goes no slave galley with oars, neither do great ships pass thereby.*

22. *For Yahweh is our judge, Yahweh is our lawgiver, Yahweh is our king; He saves us.*

23. *Your ropes are loosed; they could not hold their mast, they could not spread the sail: the booty of a great spoil is divided; the lame spoiled the spoil.*

24. *And the inhabitant doesn’t say, I am sick: the people that dwell therein are forgiven their iniquity.*

(Is. 33:20-24).

Currently America is the prey because she is permitting The Beast System (Babylon) to rape her. She has adopted Government as her god. She accepts laws legislated by men – rather than the laws of God. America’s religion, now, is the religion of man-gods, rather than the Way of Christ. And the churches of the land are propaganda centers peddling pacification programs. They only serve to distract and disable the people. The churches are complete frauds – inventions of Babylon. They have NO relation to Christ, the Apostles, or the laws of God. The churches are the mediums by which **Banking, Government, and Religion** are passed off to a blind society. Thus, the churches legitimize Babylon’s tools of destruction. Churches (all churches!), along with banks and governments, are the mortal enemies of Freedom.

Liberty cannot exist where the spirit of Christ does not reside (II Cor. 3:17). Banking, Man’s Government, and Religion are ANTICHRIST establishments. To find liberty, one must carefully avoid these.

But, America has taken these three to her breast. Indeed, these three elements have become the heart and soul of American Culture.

## THE FALL

How did America change from the “The New World” – “land of freedom and opportunity” – to a land of the blind? That is the question!

To answer this question, let us go back and resume our simplified review of American history.

We concluded that America, back

when she was called “The New World,” was free because of ONE ESSENTIAL FACTOR.

That factor was MAN’S GOVERNMENT. The Old World (Europe and Britain) had it, and The New World (America) didn’t. As in Eden, the absence of the Serpent in America allowed freedom to exist. Her shores were friendly to life, industry, and general health.

The Old World was infested with serpentism. It was unfriendly and monopolized by a few elite at the top. Therefore, a great exodus began away from The Old World and toward The New World – America. It was a natural reaction. It was bound to happen. And, if another “New World” were somehow discovered today there would be another great exodus from today’s Old World (America). People would rush in droves to a new world to escape the strangling tentacles of the beast system ... away from their old conquered lands.

America, as she was before Babylon infected her, was a land of equal opportunity. Anyone who could deal with nature and freedom could survive and prosper. The land was host to immigrants from The Old World, and a native population of Indians who had no concept of government, colonization, banking, monopolies, stocks and bonds, investment, speculation, or land ownership. The Indians were mostly hunter-gatherers with limited political structure. Their influence, and potential for evil, was generally confined to small environs of their habitations. Thus, they were naturally unable to oppress large populations or future generations.

Generally, with few exceptions, the Indians helped, rather than hindered, the British and European pioneers. However, when settlers, or government agents from The Old World, mistreated the Indians, or tried to push them off their environs or dispossess them of their lifestyle, the potential for violence grew fast – and understandably so.

In pre-colonial America, the relationship between the White settlers and the Indians was generally good. For many years they lived in peace, and often with mutual benefit to each other. If it hadn’t been for the politicians, bankers and land speculators from The Old World, the professional soldiers, etc., there probably never would have been any major conflicts between the natives and

the pioneers. The Indians probably didn't realize it at the time, but their enemy was also the White Man's enemy. Their enemy was the government (i.e., the beast system), and it followed and preyed upon the White civilization. The truth is, the Beast System was the enemy of both cultures. But, the distinction between the White pioneers and the Beast government that followed them was not well defined or understood by the Indians. Thus, the conflict became a race war.

The White Man brought industry and production ... which brought prosperity. Prosperity brought thieves and con men ... and the greatest thieves are the bankers and politicians who make up the system of government called "The Beast."

Thus, the Serpent slithered onto America's shores, into the villages, and into the lives of the settlers and pioneers ... and poisoned The New World. It spelled misfortune for both cultures.

Government schools commonly teach that the government system produces better lives and prosperity. But in fact it's just the opposite.

Before the Serpent's poison began taking its toll, pioneers and settlers from The Old World came and lived in the new land, carving out their way of life in a free environment. Any disputes that arose were small, and they were settled wherever they arose. There were no wars (as we know them).

However, when government came with its militaries, with intent to conquer, control, and drive the Indians off their land, then real conflicts arose. The invaders declared war upon the Indians by (in Indian vernacular) "taking without asking." When pushed sufficiently, the Indians often responded with violence ... often without differentiating between the common settlers and the agents of British or French governments. They all looked the same.

The Indians held the land and nature sacred. They were pagans ... but at least they were not of the Beast System. They knew nothing of the system that came from Babylon via Europe. In other words, they were ignorant of banking and politics. Their religions generally prohibited "ownership" or exclusive control of land ... by anyone. They knew nothing of parceling or sectioning off of tracts of land by boundaries for the exclusive use by any one man or group of men.

The land was sacred to them, and could not be owned or marketed. Owning and speculating on land was unknown to them. Land was to be occupied for use, but not owned.

Their extraordinary pagan view of land was interesting in that it was closer to God's law than was the European/British concept of "real estate" where men own, marketed and exploit land.

God's law explicitly states that He alone owns the land – and He entrusts it to us to use and manage only (Lev. 25:23). In other words, in a Godly society we would not "own" the land in the sense of buying or selling it. Rather, families would have 50-year rights of usage (free leases) over their designated parcels. The rights of usage would remain with a family until the Year of Jubilee (every 50 years). Then the elders (patriarchs) would re-evaluate the usage and reapportion it as needed for another 50 years. The use of the land would be without fee, tax, or loan.

On the other hand, the Babylonian system of Government and Banking was adopted in Europe and Britain. Then it found its way to America. Thus, the Beast controls the land, and enslaves the inhabitants. Land-control is people-control. Usury and the exploiting of land has become accepted forms of merchandising – all the while causing prices to increase until the common man cannot afford to buy a piece of land without a usurious bank debt.

Even those who can afford to buy land find that they do not really own it. The government always retains taxation, zoning, inspection and "eminent domain" over all land. Thus, government can tax land, condemn land, and confiscate land at any time – all this without the consent of the supposed owner. These, and many other evils, have come upon the land due to our people ignoring and/or rejecting God's laws. They opted for Man's law and Government.

Before the Beast System entered, America was a land of peace and plenty; of farmers, trappers, and hunters traveling freely and settling freely. The laws of freedom and survival were the laws of the land. Those who hurt others were liable to get hurt. Those who took lives unjustly were liable to lose theirs. Those who would not work were likely to starve. Those who honored the laws of liberty, and were good providers and neighbors, were prosperous and happy. Men were

left to protect themselves, their family, and their possessions ... without government interference. Violators of the law of liberty earned whatever violence befell them. Thieves might get beat up, bludgeoned, or shot. That was the risk of being a thief. Murderers risked being killed. The immoral and the liars were shunned, not trusted, and considered "outlaws" (they were not protected by law). Reprobates and abusers were cut off from the community because of their choice of lifestyle.

This was the law of survival and freedom – and it was relatively close to the law of God. In fact, it was a great deal closer to God's law than are the perverted laws from Congress today.

In effect, in pre-colonial America, before the Serpent System infected her, a righteous man could find freedom. He could apply the laws of God as he understood them. He could raise his family without interference. He could produce all that he was capable of producing from the land, and enjoy the fruits of his labor without taxation. In other words, it was possible for a man to enjoy the blessings of the Way of Christ if he so chose. He needed no permission from government, nor did he pay a ransom to keep policemen from harassing him or shooting him.

This freedom didn't last long, but it was great while it lasted.

This truth is not taught to our people today. But, you who are reading this know that it is the truth.

The people prospered. The communities grew. Life was good. The common hardships were small prices to pay for the invigorating and quickening experiences of living in liberty.

Those who were old enough and wise enough to remember the ways of The Old World knew that this freedom would be challenged by agents from Europe and Britain (The Old World). They knew that the money changers and the exploiters would show up as soon as it was profitable ... i.e., when commerce in The New World was sufficient to attract them.

The way of the serpent is "subtle." It is the most "cunning" system of all. The serpent system is more cunning than any of the other beast systems in the world.

The way of the serpent is the way of Babylon. It is called by many names, but it is always central rulership. Cen-

tralism, for some unexplained reason, has an irresistible appeal to foolish men. The concept is usually sold by a cunning salesman (a preacher or politician). Such a “serpent” is found in Genesis 3 where we witness the serpent system being sold to an unsuspecting and idolatrous man and woman.

The serpentish spokesman convinced the woman that God had left her without protection. He further convinced her that the “tree in the center of the garden” (representing central government and lawmaking) was “good” in spite of God’s warnings to avoid it.

Then the con was complete when he convinced the woman that by accepting the serpent doctrine (i.e., the forbidden fruit) she could be as a god, knowing good and evil – which meant that they could determine for themselves what was right or wrong. They could legislate laws to reflect their own wishes.

This clearly shows the beginning of the Beast System among the people of God. It records the outset of the battle of the ages – between God’s way, and Man’s way.

Egypt, Assyria, Babylon, Persia, Greece, Rome, Europe, Britain, and most of the rest of the kingdoms in history, opted to follow the way of the Beast – after the ancient model of Babylon. The Bible refers to this system as a “dragon,” a “serpent,” or a “beast.” The beast in the Book of Revelation has serpent heads.

Down through time, the Beast governments have dominated the nations of the Earth. However, the Way of God (i.e., Kingship of God) has been preserved also. Genesis 3:24 tells us that God provided for the keeping and preservation of His Way – the tree of life. That “Way” (of society) – that Kingship – survives even to this day (Mtt. 16:18). The blessings of heaven are available and poured out upon those who seek God’s Kingship (Mtt. 6:33). But, generally the people refuse to recognize the Kingship – just as they refused to recognize Jesus.

Thus, it was with the people of early America. Some of them realized what they had. But, too many of them overlooked the principles of freedom, and they sold out to greed and fear.

The outsiders came. They were serpents selling Serpent government. The people accepted the idolatry and worshipped the golden calf of Centralism.

The serpents started their sell by flattery. They told their victims, “*You are growing into a great kingdom. You must enter the status of all great societies.*”

Thus, they tricked gullible Americans into forgetting that it had been God – not British government – that had blessed them up to now.

Then the serpents resorted to scare tactics. They said, “You need government to protect your properties, and to guard against civil disturbances. Otherwise, your properties and lands may lose value or get stolen. You need central government to fight your battles for you and protect your investments.”

Thus, they hoodwinked the people into forgetting that God had, in the past, blessed them and showed them how to protect themselves so that war was rarely seen. Wars are the currency of governments – not the people.

Finally, the serpents offered them the oldest line in history. They said, “By accepting and becoming part of a central government you can have a hand in making your own laws. You will be part of the government itself (via representation). Thus, you can insure that your own interests are protected.”

The American settlers were ultimately tricked into thinking of themselves as gods (lawmakers) and masters of their own destinies (“*You shall be as gods ...*”). However, they forgot that it had been God’s laws – not their own – that had given them freedom. If God’s laws, and freedom, had been the key to their current success, why would they want to switch to another system and other gods?

It didn’t make sense! But, then, idolatry never does.

So, why have our ancestors always tended toward idolatry? Weren’t our ancestors intelligent beings? As a people they’ve been industrious, progressive, and inventive.

But, idolatry is so stupid! Any child can understand the advantages of independence and freedom. Why, then, couldn’t our ancestors understand it? Why did they keep volunteering into the slavery of Centralism time after time?

The Beast System cheats its people by tricking them into wrong thinking. It’s been said that “you can’t cheat an honest man” ... and perhaps therein lies the answer. Americans were cheatable because they, themselves, were trying to cheat one another. They adopted the

capitalist system based on cheating one another ... and they fell into the pits they dug for their neighbors.

As stated earlier, our race seems to have a strange inherent affinity to Centralism (Serpentism). We are irresistibly drawn toward this form of collective crime – like a moth to the flame. Our race craves slavery. Our forefathers craved slavery under their Egyptian masters. Even after suffering under slavery for 400 years, the Children of Israel feared freedom more than they dreaded slavery. When Moses led them out of Egypt, into freedom, within a few days they were complaining about their conditions and preparing to return to Egypt – to their preferred lifestyle as slaves.

Americans have read of this, but they refuse to recognize it. Instead of “slavery,” they prefer to call it “a Republic,” or “a Democracy,” or “civilized society.” Why people prefer slavery rather than freedom ... God only knows! But, it doesn’t speak well of our intelligence, or our spirit.

The pioneers had the right spirit. They came to The New World to escape the ways of The Old World. But in time they seemed to forget what drove them away from The Old World. They found freedom and success, then took it for granted. They “grew fat and kicked” (Dt. 32:15). They invited back the very institutions that had raped The Old World, and that they had crossed the ocean to escape. They were now throwing away the very thing that had attracted them to America in the first place.

Meanwhile, banker-sponsored adventurers were establishing “colonies” on these shores. Some of the colonies were established in the name of the British Crown; some in the name of the King of France; and some in the name of the King of Spain. The enemy was advancing from all directions.

“Colonialism” is a term that should have struck fear in the heart of every freedom-loving red-blooded man in 17th-century America. Indeed, there were some who understood what it really meant. But, unfortunately, again there were too many who forgot what it meant, and they gullibly accepted the serpent’s sales pitch: “... *colonies will bring trade, commerce, and all the advantages and comforts of civilization.*”

In truth, the colonies were corporate outposts for the business interests of foreign bankers. The colonies were

business ventures ... chartered, financed, and established in the name, and under the flag, of their respective foreign banks and governments. Once established, their sponsors sent their militaries to protect their investments.

As British and European merchants developed their colonies in The New World the natives realized that it had become a hostile invasion. The colonial sponsors from The Old World intended to steal their land by conquest and drive them out of their native habitat – and never give it back.

The point is, there was a big difference between “pioneers” and “colonists.” Pioneers came looking for freedom and to get away from the Beast System. They did not steal land or start wars. They did not drive natives off their land. They did not see the natives as enemies to be conquered, or chattel to be controlled and exploited. Pioneers moved to America to survive by the laws of God and nature.

Colonies, on the other hand, were corporate business ventures owned by foreign bankers and politicians. Their corporate intent was to invade, establish outposts, and expand their investment holdings.

Colonization was corporate investors grabbing real estate. By beating other banks and governments to the punch, grabbing as much land and riches as possible, they were competing at the game of world domination.

Colonies grow into nations or states. But whatever they grow into, the seed of central banking and government remains. It goes by various names: Capitalism, Socialism, Monarchism, or some other “ism.” It’s always ruled by plutocrats, and it is a weed that is hard to kill. It survives because it is the most cruel and murderous of all the world’s systems. Only two things can prevent it: God can prevent it, and an uncorrupted society can prevent it.

The Garden of God requires diligent weeding ... but, alas, like our ancient Edenic parents, we have proven to be inattentive gardeners.

So it was in early America. Greedy investors from Britain, and idolatrous Colonists, infected and spoiled this paradise called America. The Serpent again had gained access into the garden.

From that point on, the Beast gained, and freedom waned. It was a sad process of degradation disguised

as progress. Indeed, it WAS progress ... for the bankers. But for the common man it was relentless degradation away from freedom. Future generations of children would be raised under the specter of Babylonianism. Americans were brainwashed to think of it as “Capitalism,” “Democracy,” or “a republic.” They would be taught that Big Brother is a great and wonderful master, and that citizens owed their allegiance to it. They would be lulled into a stupor by the churches and their own idolatry. Churches would put idolaters at ease by teaching them that “idolatry” was only bowing to stone statues ... and that worshipping government was OK.

All the while, Americans were becoming comfortable with breaking the First Commandment (worshipping other gods). They were embroiling themselves, and their posterity, in the worst form of idolatry. Government had become their god. The churches kept assuring them that governments and kings were sanctioned by Holy Writ. They taught the people that God preferred for common people to have no personal interest in government, and that He only wanted his people to acknowledge Him with songs and prayers, and one-day-a-week attendance in a local church.

The masters had done an outstanding job of conquering a once-free people. And what’s more, the job had been accomplished with such subtlety and professionalism that the people didn’t even realize that they had lost their way.

All that was left was for the competing colonies from the various foreign governments to compete for supremacy in the New World. Spain and France were out maneuvered by the British bankers and politicians. Thus, most of the territories of America became an expansion of London Bankers and the British Crown.

## **Rule Britannia!**

The British Empire had become the most powerful empire in the world. She established colonies (corporate outposts) in nearly every continent on the face of the Earth.

But empires fall eventually. There were a few moments in time when it almost seemed that freedom would be given another chance. For instance, at one point, in the mid-1700’s, there was

an American move for independence from the British Crown. A war was fought, and the financial powers in London decided to allow the little Colonial Continental Army to “win” – ostensibly. Thus, the Colonies became “States.”

As with any major political upheaval or change, reorganization took time – time for planning and time to rearrange the minds of the common people. After the War for Independence ended, approximately five years passed before the bankers in London resumed their reorganization of the new America. During those eleven years (5 1/2 years of war, and 5 1/2 years after), people in the new States of America again experienced a form of relative freedom ... due to the lack of central organization during that interval. The states operated under a cooperative charter called The Articles of Confederation. It conferred no central jurisdiction of lawmaking, taxation, or police powers. Unfortunately, this agreement was abandoned after five years. The London bankers had a plan ... and that plan was not to be denied.

Bankers arrange and control governments by means of debt and usury. They foment wars, and then lend money to nations fighting the wars. Politicians are always owned by bankers.

Through contracts, debt and usury bankers sit atop the pyramid and control everything. Governments do their part by making laws to protect the usury banking industry. Military forces are formed by governments to force the pro-banking laws upon citizens as well as other nations via contracts and treaties.

Governments are corporate creations, formed by bankers for their own profit. Governments are corporations created by corporate charters generally called “constitutions.”

After independence was won in 1781, the London bankers allowed a few years for the heat of war to cool down in American minds. Then the serpents in London unveiled the next scheme in their agenda. In 1787 a new corporate charter was cunningly slipped into place at a secret meeting in Philadelphia ... but not without considerable opposition. There a new constitution was drawn up, and the new corporation, called The United States of America, was born.

This newborn state was delivered into the world by two noted political “doctors”: George Washington and Alexander Hamilton.

Hamilton was an agent of the London bankers. He brought in America's first central bank.

Washington was a renowned Freemason born in America of British aristocracy. He spearheaded the push for central power by rejecting the independent state militias and demanding a "Continental Army" authorized and funded by a new central power. His new centralized Continental Army, of which he was General, paved the way for the acceptance of the new central government. It all came together eleven years after the Declaration of Independence.

The new corporation called The United States of America was incorporated under a charter called The Constitution. The new charter provided for immediate supremacy over all other governments and laws in the land. It was supreme over all state laws that conflicted with it. Also, treaties the new Federal Government made with foreign entities were superior to state law. This was spelled out in no uncertain terms in what came to be called "the supremacy clause":

*This Constitution, and the laws of the United States which shall be made in Pursuance thereof (i.e., by its authority); and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitutions or laws of any State to the Contrary notwithstanding.*

—ARTICLE V

This new corporate charter provided for: (1) supremacy in lawmaking, (2) central military, (3) central funding by unlimited debt and taxation enforced by soldiers (policemen) whose salary and guns were to be paid for by taxes extorted from the people. And these are only the beginning of the abusive provisions of this constitution.

This is BEAST GOVERNMENT in all its glory!

Total power! Total control! Total unaccountability! Total deception!

It is undoubtedly the most absurd and astounding racket ever invented by the criminal mind, and the most insidious criminal organization ever worshipped by stupefied Christians.

Lawmaking by man is the ultimate idolatry. Acceptance of this kind of gov-

ernment constitutes Americans' great sin against God. This grievous sin is the same that devastated our ancestors:

- Adam rejected Yahweh's laws and adopted the concepts of Serpent Government. Adam lost his Eden. (Gen. 2-3)

- Moses led the Children of Israel out of Egypt to freedom. At Mt. Sinai they were to receive instruction from Yahweh. But some of the Children of Israel rebelled against Moses and his God. They reverted to the old Serpentism they had learned in Egypt – symbolized by the statue of a *golden calf*. Yahweh's wrath fell upon them. Some died right there, and the rest became nomads without a land of their own for 40 years (Ex. 32).

- After entering the land of Canaan the Children of Israel prospered under Yahweh's Kingship for approximately 1000 years. Then they turned away again and rejected Him as their King. They opted for the Serpent form of society again, like the nations around them. Consequently, they lost their freedom again under kings.

The following quote shows this example. It also foreshadows America's idolatry with such accuracy it almost seems like a contemporary judgment:

4. Then all the elders of Israel gathered themselves together, and came to Samuel at Ramath,
5. And said to him, Behold, you are old and your sons walk not in your ways: now appoint to us a king to judge us like all the nations.
6. But the thing was evil in the eyes of Samuel, when they said, Give us a king to judge us. And Samuel prayed to Yahweh.
7. And Yahweh said to Samuel, Hearken to the voice of the people, in all they say to you, for it is not you they have rejected, but **they have rejected Me from reigning over them.**
8. According to all the works they have done from the day I brought them up out of Egypt, even to this day, when they forsake Me, and serve other gods – so they are doing also to you.
9. And now, hearken to their voice; only you must surely protest to them, and declare to them the manner of the king who will reign over them.

10. And Samuel spoke all the words of Yahweh to the people who asked from him a king,
11. And he said, This is the manner of king who will reign over you: He will take your sons, and appoint them for himself, for his chariots and for his horsemen; and they will run before his chariots;
12. And he will appoint for himself captains over thousands and captains over fifties; and to plow his plowing, and to reap his reaping; and to make instrument of his war, and instruments of his charioteer.
13. And he will take your daughters for perfumers, and for cooks, and for bakers;
14. And your fields, and your vineyards, and your olive yards – the best – he will take and give to his servants.
15. And he will take a tenth of your seed and your vineyards – the best – and give it to his eunuchs and his servants.
16. And your menservants, and your maidservants, and your young men – the best – and your donkeys, he will take and put to his own work;
17. He will take a tenth of your sheep, and you will be his slaves.
18. And you will cry out in that day because of your king whom you have chosen for yourselves; and Yahweh will not hear you in that day.
19. But the people refused to hear the voice of Samuel, and they said, Nay, but we will have a king over us;
20. That we also may be like all the nations; and our king will judge us, and go out before us and fight our battles.
21. And Samuel heard all the words of the people, and spoke them before Yahweh.
22. And Yahweh said to Samuel, Hearken to their voice, and appoint a king to reign over them. And Samuel said to the men of Israel, Go, each of you, to your own city.

I Samuel 8:4-22

There are other examples we could point to in history. But this account in I Samuel is especially pertinent to the American idolatry which foolishly allowed the Serpent system into this land.

That leaves Americans, today, having to cope with a gigantic monster. The Bible calls it "the Beast." Beast government now occupies this once-free land. U.S. Government is not only a beast, it

is the biggest of the beast governments – symbolized by the Dragon/Serpent in the Bible. Washington D.C. has become the control center for The New World Order. From that location, the whole world is watched, policed, and controlled. The United Nations organization, based in New York, serves as an international clearing house for the criminal schemes of Capitol Hill.

Coping with this leviathan beast government is no picnic. It is difficult and dangerous at best. But we are living in a land where the beast not only reigns supreme, but is actually adored and worshipped by the very people whose necks are pinned under its foot. The actual scenario is so ludicrous it boggles the mind.

Picture a group of people coerced into slavery. And, picture the slaves tricked into thinking that their particular form of slavery is actually “freedom.” Then, picture those same slaves giving credit to their slave master for keeping them free.

Sound absurd?

Well, that is precisely the state of the majority of Americans today. They are blind because they refuse to see.

*15. For this people's heart is waxed gross, and their ears are dull of hearing, and their eyes they have closed; lest at any time they should see with their eyes, and hear with their ears, and should understand with their heart, and should be converted, and I should heal them.*

Mtt. 13:15

There is another point that has been a stumbling block and a chronic error among our people.

## THE ALL AMERICAN BOY

Thus far, I have pointed out that God declares Himself the ONLY LAWGIVER and that when man takes it upon himself to make and/or change law he makes a terrible mess of it. Thus, legislation by man is ungodly, evil, and destructive. Furthermore, I have shown that The Constitution which created and granted powers to The US Government was a document devised *of the government, by the government, and for the government*. It was never intended to be “of, by, or for the people.” It never has served the people. It CANNOT serve the

people. It was not designed to do so ... even though it was cunningly phrased to make it appear to be “for the people.”

So, consider the plight of the average American. He is raised in the public schools where he is taught that man's government is not only necessary, but that it is the best government possible. His parents do nothing to disabuse him of the lie ... because they either agree with the schools, or they consider the subject unimportant and not worth their time.

The youngster graduates from school knowing absolutely nothing about the real problems he will face in the world. However, he is confident that the government will protect his rights and make it possible for him to pursue “the American dream.”

The average high school graduate, or college graduate, is usually not fortunate enough to have been born into a family that owns a business with a career awaiting him. So, he goes out and tries to find employment somewhere ... anywhere. You can find him frying hamburgers, pumping gas, or working on a conveyer belt in a production line.

Within a few years he gets married and immediately goes into debt as deeply as his creditors will allow. He needs a car, furniture, tools, a lawn mower, a TV set, and a cleaning deposit to get into a rented apartment. Soon, he has a couple children and a large hospital debt. Next, he gets a loan to buy a home.

By this time, he is 30 years old, deep in debt, and looking forward to retirement ... because he figures he'll be just about out of debt by that time.

Now, this man has unwittingly dug himself a pit ... and he is trying to adjust and be happy in it. However, before very many years pass, he starts growing weary of debt and slavery. He begins to wonder why he cannot seem to get ahead, no matter how hard and long he and his wife work. He begins to realize that his family is not happy, and it is beginning to fall apart.

He wonders, “How can this happen to me? I've followed the rules according to ‘the American way.’ These were the rules I learned in school. I've been honest. I've worked hard. I've not caused trouble. I've never been in jail: I've always paid my taxes.”

He just can't understand where he went wrong. But, something IS wrong

... and it is becoming more and more evident. So, he begins to reexamine his life to try to find the problem.

Then, one evening when he gets home from work, his wife hands him a letter that came in the morning mail. It is from the IRS. He is shocked to read that they have reassessed his last-year's taxes and he owes an additional \$1,000 ... to be paid immediately.

A month later, the bank manager calls. Due to overdue payments the bank is repossessing their car.

A week later, a SWAT team arrives and breaks down his door, shoots his pet dog, threatens and scares his family, searches and wrecks his home, and arrests him. It turns out to be a federal drug team, and the government is confiscating his home and property under the federal RICO laws ... due to the fact that a student friend of his 15 year-old son left an ounce of marijuana in his son's room. At school, during a class on drugs, the boy's 9 year-old sister announced to her teacher that she had seen it in his room. The teacher, an avid “drug warrior,” immediately called their contact in the local police, and the “boys in blue” (black in this case) were on their way.

He is told that he may be able to reclaim his home if he can prove his innocence. The problem is, he didn't even know about the “crime” until the SWAT team arrived.

Actually, he has no idea of how to get his home back. Besides, he has no money to hire a lawyer. He is totally confused ... and figures he must be guilty since the police clearly insinuated that he was.

In all the turmoil he loses his job ... and he and his family are forced to go on welfare and move into “assisted housing.” As he has more time to think about things now, since he has no job to keep him busy, he finds his days filled with thoughts and questions no one seems able to answer. Where had he gone wrong in his life to end up in this deplorable situation? How many Americans have had this happen to them? What could he do to get his life back on track?

Where is the track?

Is there a track?

He followed all the rules for success, and yet his life is a mess. What happened?



## THE FOLLY

One day, a friend tells him about an upcoming meeting that might give him some answers. A speaker is supposed to explain what went wrong in America. He decides to accompany his friend to this meeting to see what this speaker has to say – just out of curiosity.

At the meeting, he meets other people who seem to be troubled by things similar to the things troubling him. He hears the speaker, and others, describe troubles and feelings he has had ... feelings he hadn't been able to describe before. He hears the speaker explain that the problem in America is that the people haven't understood and used the Constitution. The speaker explains, with seeming authority and wisdom, how that the Constitution can protect the people if only the people will learn its real meaning and then reconstruct their lives to align with this hallowed document. The speaker also explains that most of the taxes Americans pay are unnecessary, and that anyone who learns their rights under the Constitution will discover how to quit paying the taxes.

He leaves the meeting with his head spinning, but vows to investigate this information further. The more he thinks about it, the better it all seems to him. This could be the answer to his dilemma. Perhaps the reason his life fell apart was because he hadn't realized that the U.S.A is a government based upon the Constitution. If success requires that one operate according to the Constitution's precepts, then no wonder he had failed before. He had been ignorant of those precepts and laws.

After some months of investigation and research, he decides that the lectures he has attended, the recordings on Constitutional issues and court procedures he has listened to, and the many Constitutional newsletters he has been reading, must be right. Convinced that his troubles were the result of his own ignorance of the Constitution and of court procedure, he begins a new way of life. He is now determined to do things the right way. He is now going to learn how to win his battles. Now he is going to do things right, and succeed. He is going to court and demand his rights under the Constitution.

He files papers in courts demanding that the IRS must leave him alone.

He files suit to force the bank to return his car and pickup. He petitions the government to return his confiscated home and property. In all these cases, his arguments are based upon Constitutional law and Supreme Court decisions. He just knows that everything will work out now – now that he is finally doing things right. He just hadn't understood, before, how to deal with issues at law. It was a case of misunderstanding. He hadn't explained it properly before, but now they will listen. It was just a matter of educating one's self in the Laws of the Land. Now he would finally get his "day in court" where he would prove his innocence and get his rights restored.

Preparation for court eats up a great deal of time. The paper work, legal research, and keeping abreast of all the latest strategies of the Constitutionalist crusaders, takes its toll on him. For months now he has spent every waking hour studying legal strategies, attending meetings, and drafting volumes of papers to file in various courts.

Meanwhile, his wife becomes fully convinced that he has lost his mind. Left to herself while her husband is always gone trying to save the country ... and bone-weary from trying to raise the kids by herself, keep them fed and educated, and manage the home by herself, one day she just gives up. She gathers up the kids and goes home to her parents. That night, her husband finds out, to his surprise, that while he was chasing justice in the courts, he lost the last thing that really meant anything to him – his family. Finally the judge tells him that his petitions to the court are "frivolous and without merit."

Ten years later, living hand to mouth, having lost everything, including respect for himself and the respect of his friends, he admits that he no longer hopes for justice ... anywhere. Not even from God. The Constitution – his last hope – has failed him. The whole system has failed him. Prematurely grey, bitter, in poor health, and hopeless, he is a burned-out ward of the state. He no longer believes in anything. He is the typical American patriot of the last two decades.

An exaggerated story you say?

Well, perhaps. All those catastrophes falling upon one man may be an exaggeration. But, I can personally think of several men – perhaps a dozen or so – that I know today who fit somewhere into the scenario I've just painted. And,

losing one's home, farm, or family to the system is certainly no exaggeration.

It is heartbreaking to watch. I've seen it too many times. Men with good intentions attempting to achieve success by following the system. They want to be successful. But, they get derailed by a basic error – an error that few ever seem to overcome.

What error?

The same error that has derailed our people for eons past. The error (idolatry) of:

1. Believing in Man's Government, and
2. Looking to government for justice.

The typical "citizen" turned "patriot" ... then turned sour (from our example above) learned to hope and depend upon government while a youth in school. Thus, he was led, like a lamb to the slaughter, into the lifestyle the bankers and politicians designed for him. First he was taught in Sunday School that he must obey the rulers in government. Then his brainwashing continued in the schools. After his years in the schools, he was led into the final stage of brainwashing by then banking industry which teaches usury-debt and heavy taxation as "the American way to success."

The poor fellow had no chance. He had two strikes against him before he went to bat – and his bat was broken.

No wonder he couldn't make a living. No wonder he fell into a hopeless situation. No wonder he failed. He had bloodsucking vampires, leeches, and parasites (i.e., politicians, bankers, and preachers) all over him. He wasn't just supporting himself and his family. He was supporting the bankers and the government ... and they sure know how to spend money.

If he had known the truth about government, banking, and religion, he might have been able to avoid most of the stumbling blocks that took him down. He would have had a chance to devise a better strategy – and hopefully disabuse his own children of the myths about government that are taught to the masses.

However, being ignorant of the causes of his failures, he assumed that they were due to his own ineptitude. His attitude toward the government was based on the principle that "might makes right." The government had power

... and if for no other reason that made it right.

No one ever explained to him that the Constitution was an evil charter. It was Constitutional government that had been taxing him to death, legalizing usury-theft banking, and hiring police, judges, and attorneys to rob him of his sustenance and to kill him if he resisted.

The Constitution created a central government, and declared it to be sovereign. All the other verbiage and noble-sounding phrases in the Constitution were beside the point. A government, once in power, regardless of how it came to power, can do whatever it wants to do – regardless of what may have been written or declared in its founding charter. A government, once in power, cannot be called to task ... except by a bigger power.

Once in power, a government is a tyrant ... until something causes it to lose its power. Until then, the “tyrant” is above law. It does what it wants. It makes law. It annuls law. It ignores law ... if it so desires. It can create corporations (fictitious entities). It can create and/or change government currency. It can delegate authority to other agencies ... or to outside corporations, like a central bank (the FED) that can create, distribute, and control that currency. It can tax the people. It can hire mercenaries and militaries to defend itself and force the people to comply with its changing laws.

You see, all those other high-sounding statements in the Constitution were nothing but subterfuge to disguise the important words – the words that declare that the Federal Government has supreme powers. The rest of the wording was only sugar coating to cover-up the taste of the bitter pill.

Some folks who read this will reject my comments out of hand. They’ll say, “Oh, he just doesn’t understand the Constitution and court procedure.” They may assume that I’ve dismissed the Constitution, and the courts, without giving them much thought. But, I assure you this is not the case. I’ve studied law and the Constitution for years, and I’ve worked with some of the best-known and most sincere “patriots” and “paralegals” in America. I’ve seen the courts from within, and without. I’ve read the strategies from a hundred patriots – thousands of pages of court records, claims, suits, and other papers filed in the courts ... or proposed to be filed.

Yes, I too was once a Constitutionalist. I, personally, spent years pursuing that deception. I’ve been close to many others who have also pursued it long enough to know it doesn’t work. Anyone who claims it does work is either fooling himself, or hasn’t been at it long enough to understand what he’s up against.

The key to understanding the error of patriots who believe in the U.S. Government is its “SOVEREIGNTY.” The word “sovereignty” is “**TYRANNIA**” in Greek & Latin. There are NO checks and balances where tyranny is concerned. A sovereign (a tyrant) has no constraints except conscience – and a government has no conscience.

The Constitutionalist may argue that LAW, rather than the government, is sovereign in our land. This argument is absurd on the face of it, for if law were sovereign the government couldn’t create it, change it, or annul it. No one will deny that the U.S. Government creates, changes, and annuls law. Even the Constitution is subject to change by amendment, by reinterpretation, or by creation of new laws.

There is only ONE kind of law that is not subject to change or annulment: GOD’S LAW. That should tell us something.

In 1787, America’s new Constitution went into effect. In 1790, Alexander Hamilton (the main architect and apologist for the Constitution) presented to Congress his plan to establish a national bank corporation. His plan passed Congress in February 1791. President Washington, feigning fairness and objectivity, requested Hamilton, Jefferson, and Randolph to submit written opinions on the question of whether or not the new U.S. Government could create such an institution without violating the Constitution.

Randolph and Jefferson both submitted opinions opposing the measure, explaining that the powers granted to government by the Constitution did not include the power to create such a corporation.

Jefferson said that such a corporation, created by the Federal Government, would further violate the laws of *mortmain* (perpetual ownership), *alienage* (aliens holding lands in the U.S.), that the lands would be wrongly transmitted to a line of successors, that the lands would be out of reach of forfeiture, or

*escheat*, and that it would constitute a monopoly, and that the federal corporation could make laws higher than the laws of the states.

Jefferson had refused to participate in the making of the Constitution. Perhaps the reason was because he foresaw that the new document would precipitate this kind of power struggle.

Hamilton, on the other hand, argued that none of these objections were relevant to the question. He said, in essence, that “sovereignty” is automatically assumed by the very nature of government itself ... and that it includes the power to create whatever is needed or required. He said:

*“... every power vested in a government is in its nature sovereign, and includes, by force of the term a right to employ all the means requisite ... to the attainment of the ends of such power.*

*... For it is unquestionably incident to sovereign power to erect corporations, and consequently to that of the United States ...”*

Washington accepted Hamilton’s explanation, and Hamilton got his corporate charter for his national bank. This opened the door to corporate institutions of all kinds. Today the world is overrun with massive corporations that consume and control everything.

## **SO WHERE DOES THAT LEAVE US?**

What is the point of this explanation? Aside from exposing the true builders of this “illustrious” government, it shows that the question of sovereignty was one of the first issues settled by the new government created in 1787 by the new Constitution. The Federal Government demanded SOVEREIGNTY.

The question was forever settled. The Constitution had created a runaway Federal Government that could not be governed – not even by its creators.

At times, the central government feigns acquiescence or submission to the states or the Constitution ... only because they want to sustain the illusion for the sake of keeping the people passive and inattentive. This illusion (that the government is governed by the Constitution) is useful also to the court system. In essence, it keeps the fake

"complaint department" operational.

You know how the complaint department works, don't you? It was an invention of modern efficiency experts who knew that the customers, or employees, of large corporations need an outlet for their frustrations. A complaint box was created and mounted to a wall where the people had easy access to it. When people got mad they were to write down their complaints on small pieces of paper and deposit them into the box. The complaints would then be read by the directors of the corporation, and appropriate measures would then be taken ... thank you very much.

The complaints went into the box every day. Every day the employers removed the complaints from the box ... and threw them into the shredder.

The process gave the employees a way to let off steam. It was a good stroke for corporate management. It kept the employees from taking their complaints elsewhere. They gullibly handed their complaints over to the very men about whom they were complaining. The management knew what to do with complaints. They feigned interest and sincerity ... then they trashed them and laughed up their sleeves.

This approximates the attitude of the courts. Their motive is similar: i.e., keep the natives from getting restless by feigning interest in their complaints, thus keeping alive the illusion that they operate for the benefit of the people.

That, of course, is a joke. Courts operate for the benefit of government.

Government, once in power, does what it wants. To hold government in check, or to control it, it would take a power greater than that government. It would take a bigger government, a more powerful entity, etc. Of course, Yahweh or his Son Jesus can stop them ... when we stop worshipping it. But God lets us have what we worship ... like the golden calf (Ex. 32:19-20).

Yet, the "Patriot Movement" continues to mislead people into hoping for justice from courts created to protect government. And the Constitutionalists still listen to speakers brag about "victories" in the courts won by means of the Constitution. They collect speaking fees for misguiding desperate clients who are grasping at straws, hoping to salvage their properties that are under siege by the government. At meetings, the self-acclaimed Constitutional gladi-

ator sells worthless strategies to vulnerable, desperate people who lack experience in those areas.

The Constitutional gladiator, in effect, tells them that he has devised a complicated strategy that will give the people mastery over the government agency (like the IRS) that is oppressing them. He says that his strategy will restore their freedom and property. He directs people back to the Constitution. He, in effect, tells oppressed people to seek help by petitioning their oppressors. So they go to the government courts to complain about something the government did, or didn't do.

The courts – like the police – are appointed and controlled by the government to defend the interests of the government. These courts listen to the complaints (much like the corporate complaint box) and then summarily dismiss them ... without so much as an explanation.

Yet, patriots refer the captives back to their captors. Why do Americans continue trusting their slave masters to make them free? Why do they continue to pray to their enemy to grant them fairness and justice? Why do Christians think it is necessary to get approval from Babylon? And, why do they keep praying for God's blessing upon the Beast System? It is insane!

## THE ANSWER

Relief cannot be found by looking to our oppressors.

Where, then, can we go for help?

The answer is simple. In fact, we could go almost ANYWHERE else and find more help than from the government.

Of course, my recommendation is that we can, and should, go TO JESUS for answers and relief. He can help.

But, how can we fight the Beast? He is so big, and we are so small.

The Beast System continues ONLY by public favor. Beast systems require public approval. That is not to say *by the vote* – but by the general approval and favor of the people.

Therein is the definition of the problem ... as well as its cure. The Beast thrives and grows upon public trust, favor, and gullibility. To weaken the beast all that is needed is public distrust, disfavor, and critical insight.

Our number-one problem today is idolatry (worshipping men as lawgivers).

The remedy is to **STOP WORSHIPING MEN**. That, alone, would stop the power of the Beast System. To accomplish that, we only need to open our eyes and see it for the monster that it is. Then we will stop trusting government, stop favoring government, and stop believing that men should make laws. That especially goes for those who are still going to the government's courts to beg for relief from government. It is folly!

When it is generally accepted by the common people that "*The best government is the least government*," then we'll begin to see a decline in oppression and misery.

Americans have been worshipping the idol of man's government. When that idolatry stops, we'll see freedom again.

Pray that Americans will open their eyes.
